



DAYCARE

Stonehill Kennel and Farm agrees to provide reasonable care, maintain facility sanitary standards, and to ensure proper safe enclosures. Daycare pets will be properly monitored and housed in clean, safe quarters. All pets that attend daycare or otherwise handled are cared for by Stonehill without liability on the Stonehill's part for loss or damage from disease, death, theft, fire, injury to persons, injury from other pets, or property by said daycare pet or other unavoidable causes, due to diligence and care of having been exercised by Stonehill. Pet Owner agrees that they shall be solely responsible for any and all acts and behavior of said pet while it is in the care of Stonehill. This includes damages to kennel structure and/or kennel property. Initial _____

VACCINATIONS + PREVENTATIVES + SPAY/NEUTER

Stonehill specifically requires all pets to be vaccinated against communicable diseases to attend daycare. Stonehill reserves the right to refuse admittance to any pet that shows signs of illness or that does not meet the vaccination requirements. Despite these precautions, Pet Owner acknowledges that Owner's Pet will be in an environment with other pets during daycare, and understands that any pet may harbor or spread a communicable disease. Pet Owner releases Stonehill from, and waives all claims and liability against Stonehill for, all losses, damages, costs and expenses arising out of or in connection with any communicable disease, any viral bacterial or parasitic infections contracted by Owner's Pet during daycare including but not limited to coughing, sneezing, vomiting or diarrhea. Pet Owner specifically represents to Stonehill that Pet has not been exposed to ANY communicable disease within a 30 day period prior to boarding.

- ***Stonehill Kennel and Farm requires proof of current Rabies, DHLPP/DHPP/DAPP and Bordetella (Kennel Cough) vaccinations.***
 - The Bordetella vaccine is not 100% effective. Stonehill makes no guarantees in regards to the Bordetella vaccine and risk of infection in our care.
- ***Stonehill Kennel and Farm highly recommends that all dogs are also vaccinated against Canine Influenza but this is not a required vaccination for stay.***
- Current veterinary verifications must be provided to Stonehill 48 hours prior to check in dates.
- In addition to vaccinations, all pets should be flea and tick free. ALL Pet Owner's are responsible for routine upkeep to ensure their own pets health and preventative care.
- All pets are checked for external parasites (fleas/ticks) upon entry to the facility. If any external parasites are found, they will be treated accordingly and Pet Owner will be responsible for those expenses.
- All daycare pets **MUST** be spayed/neutered by 6 months of age or sooner if pet goes into heat before their 6 month birthday. Pets showing signs of heat will not be permitted to attend.
- Owner understands and agrees to abide by Stonehill's prevention policy. Initial _____

MEDICATION ADMINISTRATION

If Pet Owner provides medication to be administered during daycare, Stonehill Kennel and Farm will administer basic medication according to Pet Owner's directions at no charge. Stonehill is unable to administer insulin to any pet attending daycare. Initial _____

ON-SITE MEDICAL CARE

Benadryl, imodium, probiotics, CBD, saline wash, hydrogen peroxide, neosporin, bandages, etc are routine treatments for minor health concerns. Pet Owner agrees in the event of minor injury or illness that Stonehill is permitted to treat Owner's Pet as needed based on the situation. Initial _____

EMERGENCY MEDICAL CARE

If Owner's Pet becomes ill or if the state of the Pet's health requires professional attention, Stonehill Kennel and Farm, in its sole discretion, may engage the services of a veterinarian or administer medicine, or special diet, or give other requisite attention to the Pet and the expenses will be paid by the Pet Owner. ABANDONED DOG PROCEDURE

Unless otherwise required by applicable law, if you fail to pick up your dog(s) by the designated time and have failed to make satisfactory alternative arrangements with Stonehill Kennel and Farm, Stonehill will continue to

provide basic service to ensure the dog's health and safety, and charges will continue to accrue. Stonehill will make best efforts to contact you using the information you provided, advising you that if your dog(s) is not picked up within a reasonable time period, your dog(s) will be deemed to be abandoned and that Stonehill will deliver the dog(s) to a third-party adoption partner or other reputable animal welfare organization. You understand that you may lose ownership of your dog(s) under these circumstances. If you fail to pick up your dog(s) for any reason, you release Stonehill from all further liability and responsibility for your dog(s). You shall remain liable to Stonehill Kennel and Farm, for all unpaid charges, including without limitation the court costs and reasonable attorneys' fees incurred in the collection of such charges. PAYMENT POLICY + DAYCARE PACKAGES

All daycare pet fees MUST be paid before Pet is released to the Pet Owner. If fees ARE NOT paid, Pet will NOT be released. Pet Owner is responsible for paying the full daycare fee, whether the daycare stay is shortened due to any reason. All daycare packages are non-refundable and expire after 1 year. Unused daycare days after 1 year will not roll over into the next year. All daycare packages are listed on our website and can be pre-purchased or purchased at the time of pet drop off or pick up All checks returned for non-sufficient funds will be charged a fee of \$35.00. All credit card transactions require an additional 3% terminal fee. Initial _____

OPEN OFF LEASH PLAY RISKS AND ASSUMPTIONS OF LIABILITY

I understand that the leash-free environment at Stonehill Daycare provides dogs the opportunity to play in close physical contact, including with their teeth and paws. I acknowledge that no amount of supervision or personalized care by Stonehill, its agents or employees, can prevent the possibility of injury or illness to my dog. I understand that daycare at Stonehill is a cage-free service. I accept the risks involved and agree that I am solely responsible for any damages that result from injuries caused by my dog while at Stonehill. I agree to indemnify and hold harmless Stonehill from any and all claims, liabilities, costs and expenses, including court costs and attorney fees, arising out of any harm or injury caused by my dog to other dogs or persons. I authorize Stonehill to do whatever is deemed necessary for the safety, health and well-being of my dog and I agree to assume full financial responsibility for any and all medical expenses incurred. I expressly waive and relinquish any and all claims against Stonehill, its employees, agents, and representatives for any injury, illness, or harm to my dog. Under no circumstances will Stonehill be liable for consequential damages or damages beyond the replacement value of my dog. Initial _____

REPRESENTATIONS + LIABILITY

- I agree that I am the owner (or designated agent of the owner) of the dog(s) and am fully authorized to enter this agreement.
- I understand and agree that Stonehill Kennel and Farm is relying on my representations of my dog's (dogs') health and behavior. I further understand and agree that Stonehill Kennel and Farm and its staff will not be liable for any health problems that develop. I agree and understand that Stonehill Kennel and Farm reserves the right to deny admittance to my dog(s) at any time for any reason.
- I understand and agree that Stonehill Kennel and Farm will not be liable for any injuries or illnesses that occur as a result of my dog(s) attendance, provided that reasonable care and precautions are followed.

- I understand that group exercise and group play are situations where dogs co-mingle in groups, and if I have given permission to Stonehill Kennel and Farm to allow my dog(s) to participate in any group activity. I understand and acknowledge that there are inherent risks when dogs co-mingle, including, but not limited to, bites, scratches and sore muscles.
- I understand that Stonehill Kennel and Farm is not a veterinary establishment and does not practice veterinary medicine. I understand and agree that if my dog(s) become ill or injured, or if the state of the dog(s) health requires medical attention, Stonehill Kennel and Farm, in its sole discretion, may engage the services of a veterinarian and/or administer medicine or give other requisite attention to the dog. Stonehill Kennel and Farm staff will make their best efforts to notify me in the event of a serious illness or injury using the contact information I have provided to Stonehill Kennel and Farm. I understand that I am responsible for providing updated contact information. I agree to assume full financial responsibility for any and all expenses incurred, and I release Stonehill Kennel and Farm, and its staff from any and all responsibility for, or claims, damages, debts, arising out of or related to such medical care, including, but not limited to, transportation to/from the veterinary clinic and choice of veterinarian and animal hospital.
- I certify, to the best of my knowledge, my dog(s) has not been exposed to any communicable diseases with the past 30 days. I agree that I will notify Stonehill Kennel and Farm of any known exposure of my dog(s) to communicable diseases and will keep my dog(s) out of playcare and will provide a veterinary certification of fitness for playcare to be admitted or readmitted. I also agree that I will maintain current vaccines for my dog(s) and provide certification to that effect upon initial evaluation and periodically as requested.
- I authorize Stonehill Kennel and Farm to obtain medical and vaccination records for my dog(s) from my veterinarian, and I hereby authorize my veterinarian to provide these records to Stonehill Kennel and Farm. I understand and agree that I am solely responsible for any and all acts or behavior of my dog(s) while in the care of Stonehill Kennel and Farm. I release Stonehill Kennel and Farm from any liability arising from my dog(s) attendance at Stonehill Kennel and Farm and accept full responsibility for any and all costs for injury to staff or other animals or damage to facilities caused by my dog(s). I hereby release Stonehill Kennel and Farm of any liability and I further agree to indemnify and save them harmless against any and all claims arising from my dog(s) attendance at Stonehill Kennel and Farm, including but not limited to all costs, damages attorneys fees, expenses and liabilities in connection therewith.
- I understand that in an emergency event, such as a natural disaster, every effort will be made to contact me to retrieve my dog(s). I agree that Stonehill Kennel and Farm, in its sole discretion, is authorized to transport and/or make temporary alternative arrangements to house and care for my dog(s) until I retrieve my dog(s).
- I understand and agree that my dog(s) may be photographed, videotaped and/or recorded and that Stonehill Kennel and Farm retains all rights to use, and proceeds from use of, images.
- I understand that this agreement covers the current relationship between Stonehill Kennel and Farm and me. Each time I bring my dog(s) to Stonehill Kennel and Farm, I am affirming the terms of this Agreement and the truthfulness and accuracy of all statements I make in this Agreement.

I have read and understand this entire agreement, I have had an opportunity to discuss it to my satisfaction with a representative of Stonehill Kennel and Farm, and I agree to its terms.
